PUBLIC COMMENT – None

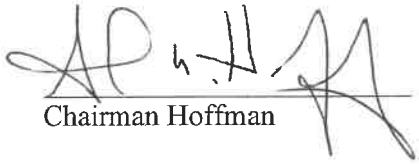
